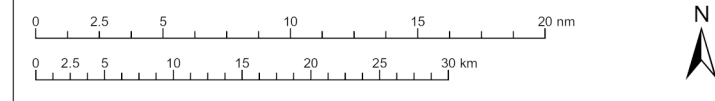

**Figure 8.5 Broadscale Habitats (EUSeaMap, 2021)**



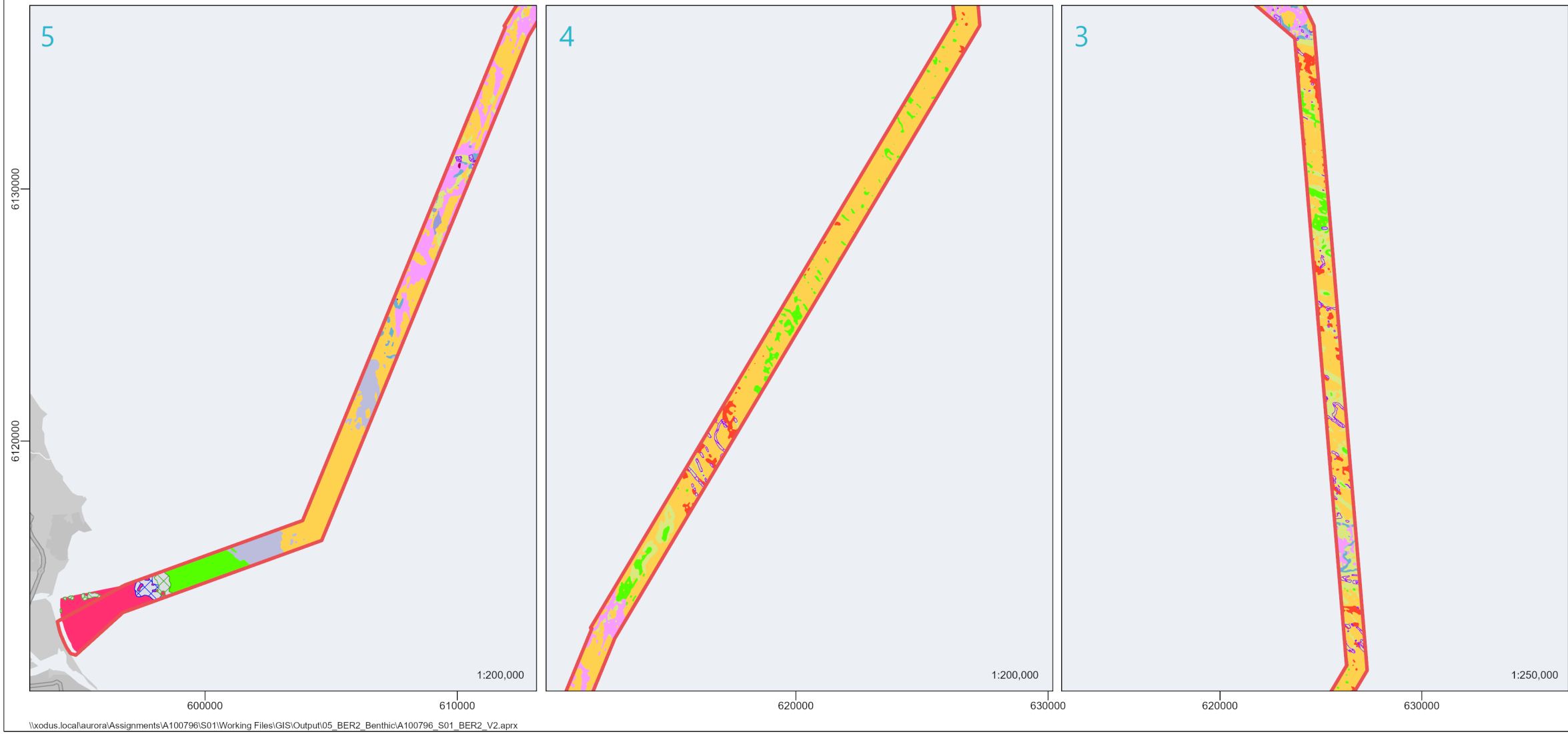

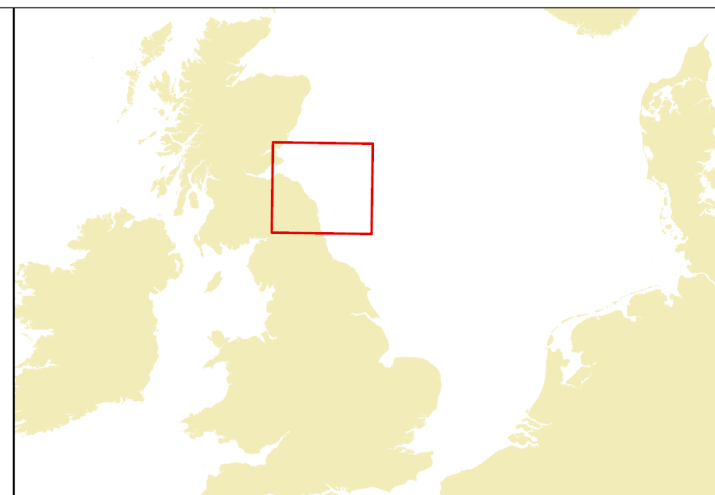

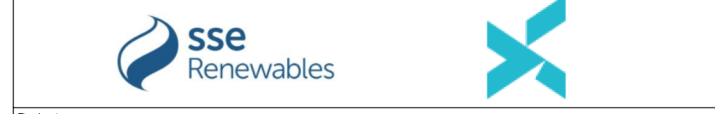

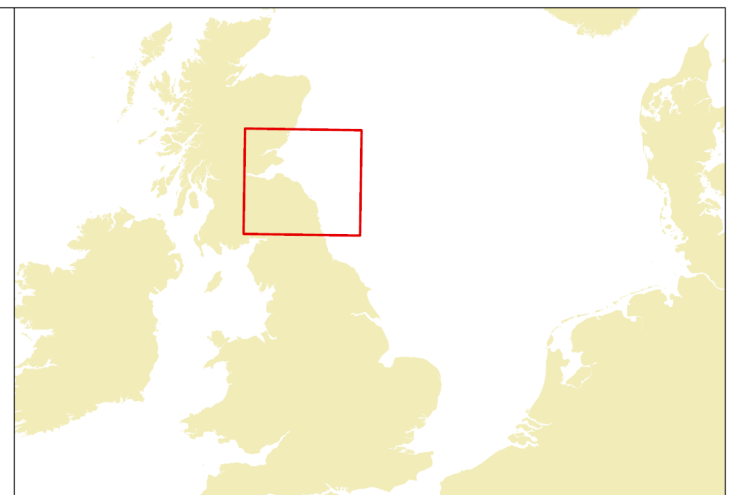
